**TEN-YEAR LIMITED WARRANTY**—This CARRIER CORPORATION (herein after referred to as "COMPANY") product is warranted to be free from defects in material and workmanship under normal use and maintenance for a period of ten years from the date of original installation. A new or remanufactured part to replace the defective part will be provided without charge for the part itself through a qualified COMPANY dealer or servicer, PROVIDED the defective part is returned to our distributor. The replacement part assumes the unused portion of the warranty. The disposable media filter requires periodic replacement depending upon the amount of use and is not covered under the above warranty.

**THIS WARRANTY DOES NOT INCLUDE ANY ADDITIONAL LABOR ALLOWANCE** or other costs incurred for diagnosing, repairing, removing, installing, shipping, servicing or handling of either defective parts or replacement parts. SUCH COSTS MAY BE COVERED BY a separate warranty or service agreement provided by the installer.

**LIMITATIONS OF WARRANTIES**—ALL IMPLIED WARRANTIES (INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY) ARE HEREBY LIMITED IN DURATION TO THE PERIOD FOR WHICH EACH LIMITED WARRANTY IS GIVEN AND APPLIES. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU. 6. COMPANY products installed outside the continental U.S.A., Alaska, Hawaii and Canada.
7. ANY SPECIAL, INDIRECT OR CONSEQUENTIAL PROPERTY OR COMMERCIAL DAMAGE OF ANY NATURE WHATSOEVER. Some states do not allow the exclusion or limitations of incidental or consequential damages, so the above limitation or exclusion may not apply to you.
